THE SHORT-TERM, TEMPORARY PROGRAMS AT THESE SITES ARE DESIGNED TO ASSIST HOMELESS AND/OR DISADVANTAGED MEN ACCESS BASIC NEEDS WHILE ASSESSING THE FACTORS THAT LED THEM TO EXPERIENCING HOMELESSNESS. BREAKFAST, LUNCH, DINNER, SHOWERS, CLOTHING, DAY ROOM, CHAPEL SERVICES, AND CASE MANAGEMENT (WITH REFERRALS TO ONSITE AND OFFSITE SOCIAL SERVICE AGENCIES) ARE PROVIDED. MEDICAL SERVICES ARE ALSO AVAILABLE.
